"Ready for Relicensing – Child Care Licensing Rule Training" We had a successful first training session on Feb 24<sup>th</sup> with FCCI loaning us their venue and getting the word out. There were over 100 attendees! This training is being repeated on March 24<sup>th</sup>, April 9<sup>th</sup> (w/Somali interpreter), and April 22nd, 6:30-8:30pm at 2117 Campus Drive SE, Rochester. There is no cost or pre-registration for this training. We will then be looking at scheduling once or twice a year. \*\*\* We believe the best preparation for your relicensing visit is to literally walk through your home as you complete the licensing checklist sent to you prior to each relicensing visit. \*\*\*

<u>The supervisor is getting out of the office more!</u> In an effort to meet more providers I will be doing home visit with each licensors at least twice a year. Hope to see you soon.

<u>Mass mailing:</u> Hopefully our mass mailing will already be in your hands by the time you read this. What is included in the mass mailing?

- A) <u>Forms</u>. It seems like forms are constantly being updated. We recommend that you always go to the Olmsted County website when looking for a form. <u>www.co.olmsted.mn.us</u> Attachment in mass mailing will give you detailed directions on how to find forms
- B) Training / Trainings finally! (See two attachments in mass mailing)
  - 1. <u>Caregivers: Roles, Definitions, & Training Requirements</u> this is a grid/guide we put together. Hopefully we got it right. Subject to change if we don't have it right and/or due to future changes.
  - 2. <u>TRAINING IMPLEMENTATION TIME FRAME</u> this grid shows your licensing expiration date from which you can then determine when the annual training hours go from 8 to 16 hours.
- C) <u>Workers' Compensation</u> in the mass mailing there is the article from Mr. Tom Copeland and the Minnesota Department of Labor and Industry form that you must complete. You must send us a copy at application and renewal.
- D) Feb 19, 2014 MN Department of Human Services News "Infant deaths in child care setting fell dramatically in 2013 ......" (see attachment in mailing)
- E) <u>Sleep fines</u>. We know that providers are worried about sleep fines. We too would rather you spend \$200 on something other than a sleep fine. We have tried to clarify when we must recommend a sleep fine. See attachment in mass mailing.
- F) Your notarized signature: You must complete an application at every relicensing and you will now see a notary section on the signature page. We have been directed that we only need your notarized signature once. Your application will be considered incomplete if not notarized and returned to you. 245A.04 Application for Licensure, subd 1, (f) When an applicant is an individual, the individual must provide the applicant's Social Security number and a notarized signature of the applicant.
- G) Attendance record check: There is no form, see attachment for direction in mailing.
- H) Background Check forms: Reminder these are TWO-sided forms, we need the front and back.


