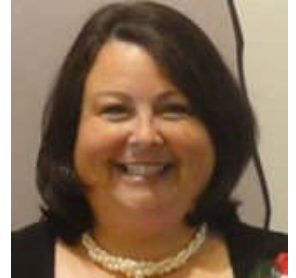

On June 30th an important Supreme Court ruling on the Harris vs. Quinn was handed down that affects the unionization of childcare providers. 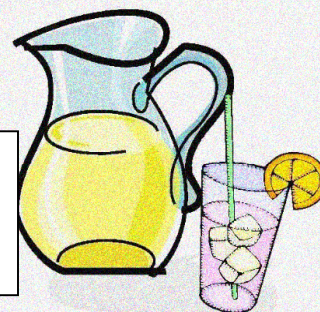

Fire Extinguisher Inspection

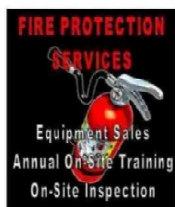
At the September 8, 2014 Workshop!

Olmsted County Licensing Notes

Dogs. Man/Woman's best friend. Who doesn't love them? Unfortunately we have had four reports of dog bites in the past few months. As a licensed child care provider you must exercise caution and additional supervision when dogs are present. Dogs can be reactionary and may bite with little to no obvious provocation. Here are our four incidents: #1) child was bitten at a park by a dog that had gotten loose from its yard; #2) child was bitten at a park, the child had permission of the owner to pet the dog; #3) child was bitten on the hand as both the child and dog were playing and going for a ball at the same time, skin was not broken; and #4) child was bitten, dog may have been reacting to protect food it was eating. Only #4 was a provider's dog, this dog had bitten other children and the provider failed to take steps to ensure no additional children would be bitten.

Provider reminder regarding animal bites:

- Provider must notify their licensor of any injuries that require treatment by a physician.
- DHS Licensing Checklist, page 4, #3 asks: Have there been any animal bites since your last renewal?
- Parents of a child whose skin is broken by an animal bite or scratch, are notified of the injury on the day the injury occurs. *Licensing Rule 9502.0435 subp 12 Pets. F.*

Other city and state laws to be aware of, for example:

*** City of Rochester, 106A.17 Animal Bites:** Whenever any animal shall have bitten a person or there is good reason to believe that such animal has bitten a person, such fact shall be reported within 24 hours to the county health department.

***Minnesota Statutes, 347.22 DAMAGES, OWNER LIABLE.** If a dog, without provocation, attacks or injures any person who is acting peaceably in any place where the person may lawfully be, the owner of the dog is liable in damages to the person so attacked or injured to the full amount of the injury sustained.

A friendly reminder that you must report to the agency (9502.0375 Subp 1 & Subp 2):

- any suspected physical abuse, sexual abuse or neglect of child
- within 30 days of any changes in the regular membership of the household (including a child's 13th birthday) or the addition of an employee (contractors, substitutes, helpers, etc)
- within 48 hours after the occurrence of a fire that requires the service of a fire department
- immediately after the occurrence of any serious injury or death of a child. A serious injury is one that is treated by a physician.

2014 Legislative changes / amendments.

245A.02 Subd 19 – School age is now defined as a child who is at least five years of age, but is younger than 11 years of age (effective 7/1/14)

245A.15111 – Contractor Serving Multiple Family Child Care License Holders. Contractor may request the county maintain a record of a cleared background check and training, must be updated at least every two years.

245C.04 Subd 7 – Contractors may service multiple family child care license holders. One background study is transferable. You will still need to notify your licensor of your intent to use a "contractor" and the agency will issue a clearance letter specific to your license.

MS 2012 Sec 14.414 Subd 2 – Smoking e-cigarettes is prohibited in the home during the hours of operation.

Court Ruling on Child Care Unionization!

On 6/30/2014, the Supreme Court of the United States ruled on Harris vs. Quinn, ultimately deciding that home care and child care providers are NOT public employees. Fair share fees are a violation of the 1st amendment.

Q and A: Harris v. Quinn Supreme Court Ruling and the Impact on MN Child Care Union Effort

The Supreme Court ruling in Harris v. Quinn on June 30, 2014, is going to impact the child care union effort here in MN. The ruling states that individuals who indirectly receive state subsidies based on their clientele cannot be forced to pay compulsory union fees (fair share). Harris v. Quinn is a case based on home health care assistants. This ruling extends to family child care providers.

Q: Can a union still be formed in MN?

A: Yes. A child care union can still be formed. Organization of the union can occur as set forth in the Child Care Representation Act of 2013. If the measures to call for a vote in the Act are met, child care providers can vote to form a union.

Q: If a union should win an election, how will the ruling in Harris v. Quinn impact MN child care union dues?

A: Any child care provider who voluntarily joins the union will become a full union member and will be responsible for full union dues. The ruling in Harris v. Quinn set legal precedent needed to ensure victory on the fair share portion in the Minnesota challenge Parrish v. Dayton. As long as Parrish v. Dayton proceeds in the court, it will guarantee that any child care provider who chooses not to join the union will not be required to pay a fair share fee, whether in the defined bargaining unit or not.

Q: Did the ruling in Harris v. Quinn extend to exclusive representation?

A: No. Harris v. Quinn did not challenge exclusive representation, only fair share fees. Per the Child Care Representation Act of 2013, a union would still have the ability to gain EXCLUSIVE representation of child care providers in the bargaining unit as defined in the Act.

Q: Can a union organizer come to my door to solicit support now?

A: Yes. AFSCME-CCPT has indicated in news reports that it will continue organizing. Child care providers can anticipate further door knocking and should clearly understand anything they are asked to sign by a union organizer. A signature on a card may indicate your authorization to become a member of the union, and you will be responsible for membership dues.

Q: Can the union petition for an election now?

A: No. Parrish v. Dayton, the lawsuit filed by Minnesota family child care providers, with the support of the National Right to Work Legal Defense Foundation, won a temporary injunction halting the union's ability to petition for an election pending Harris v. Quinn. The 8th circuit court of appeals will rule shortly whether or not to lift the injunction or allow Parrish v. Dayton to move forward and receive a ruling on the merits of the case.

Q: What is the basis of Parrish v. Dayton and when is a ruling anticipated?

A: Parrish v. Dayton is similar to Harris v. Quinn, both with First Amendment challenges. In addition to challenging the fair share fees, it also challenges EXCLUSIVE representation. Parrish v. Dayton was heard in the 8th Circuit Court of Appeals on May 15, 2014 and a ruling is expected shortly.

The FCCI Advocacy Committee is thrilled to share our successful work in the 2014 legislative session!

First, FCCI legislation makes it easier for our community of independent contractors like music/zumba/craft instructors, and independent substitute care providers to serve your program. Within a county they will need only 1 background study every 2 years, and be in compliance with any needed training. When you decide to use an independent contractor, contact your licensing unit to be sure your independent contractor has an approved background study on file. Let your licensor know you will be using their service. (Effective July 1, 2014) [245A.1511 \(not available on-line yet\)](#) and [245C.04 subdivision 7](#)

Next, FCCI's legislation created consistency with the SUIDS and AHT training requirement. Beginning July 1, 2015, SUIDS and AHT training can be completed in person or through an approved on-line course once every two years and on the off year taken by video. [245A.50, subdivision 5](#)

Our final piece of legislation assures family child care providers that they cannot be issued a correction order in regard to safe sleep specific to [245A.1435b](#) unless there is evidence that a violation has occurred when and infant is present in care. (Please note that the individual statutes linked here may not reflect new legislation until after July 1, 2014.)



It was with the amazing support of **Senator Carla Nelson and Representative Kim Norton** our legislation successfully made its way through the legislative process. A special thank you to them and the DHS staff who worked with us on our legislative agenda. Additionally, thanks to the associations who endorsed the FCCI bill; the Minnesota Licensed Family Child Care Association, Dodge County, Hennepin County, Ramsey County and Scott County Family Child Care Associations. And finally, to each provider who took time to send in written testimony and to provider Jackie Harrington for making the trip to St. Paul for in person testimony in committee. THANKS to everyone for their part!

Please note there was other legislation introduced by another group which redefines "school age child". School age child now means a child who is at least five years of age but younger than 11 years of age. Simply, your 5 year old is "school age" on their 5th birthday. (Effective July 1, 2014) [245A.02, subdivision 19](#)
