Are You Preparing to RENEW Your CDA?

Did you know?

Beginning October 1, 2015

the Council will launch a new, streamlined renewal process.

What can you expect from this new process?

- You will be able to upload your documents directly into YourCDA. **No more need to fax or e-mail your supporting documents to the Council!**
- **You will receive the CDA renewal preparation packet FREE as part of your renewal fee.** The updated CDA Renewal Preparation Guide will ensure that you have an efficient application process.
- **Your renewal application can be processed faster and more efficiently!** This is especially true when you apply online.

Effective October 1, 2015, the renewal processing fee for the online process will increase to \$125.00; paper processing fee will be \$150.00.

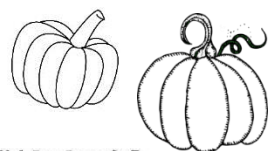

APPLE PIE FRIES

Apple Pie Filling

1 Egg

1 tsp Cinnamon

1/4 tsp Nutmeg

1/4 cup Sugar

Sparkling Sugar Caramel Topping for dipping



S'Mores Mix



♦One box golden grahams

♦One bag of mini marshmallows

♦As many choc chips as you want

♦Optional peanuts

Mix together & enjoy!

- ♦Preheat the oven to 350. Spray cookie sheet with non-stick spray or use silicone mat and set aside.
- ♦Allow crusts to warm slightly to make them easier to work with. Dust work area with flour and slightly roll out crusts.
- ♦Pulse in food processor a couple of time or use a knife to chop pie filling into smaller pieces.
- ♦Spread apples over top of 1 crust leaving about 1/8" uncovered at edges. Place other crust on top.
- ♦Cut into 1/2" strips and then cut to fry sized lengths.
- ♦Beat egg in bowl until well blended. Mix together sugar, cinnamon and nutmeg. Brush tops with egg wash and sprinkle lightly with sugar mixture. Then sprinkle with sparkling sugar to resemble salt.
- ♦Transfer to prepared baking sheet. Bake for 15-20 minutes or until golden brown



Zoodles

Use a vegetable peeler to cut each zucchini into lengthwise strips about 1/4" thick. Turn zucchini slightly after cutting each strip to work evenly around the outside, stopping when you hit the seeds at the core. Discard cores. Cut slices lengthwise into 1/2" ribbons.

Boil water in steamer (or large saucepan) over high heat. Place zucchini in steamer basket; cook for 2-3 minutes, or until tender. Remove from heat and serve immediately with your choice of sauce.

***Substitute spaghetti squash for zucchini. **Try using a spiralizer to make the 'noodles'*

♦3 ripe medium bananas ♦3 Tbls all-natural peanut butter ♦4 tsp chopped dark chocolate ♦Sliced almonds

Place sliced bananas in the freezer for 4 hours; or until completely frozen.

Place bananas and peanut butter in blender (or food processor); Blend until smooth and if needed, add a little almond milk for a creamier texture. Serve immediately topped with chocolate & almonds!

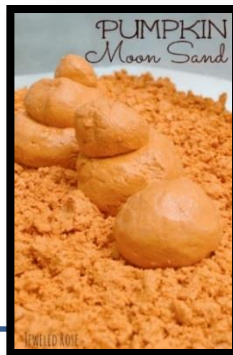

Pumpkin Moon Sand Play Recipe

- 4 cups of play sand
- 2 cups of corn starch
- 1-3 cups of water
- Pumpkin pie spice
- Orange food coloring, liquid watercolors, or powdered paint

In a sensory bin or similar container combine all ingredients and mix well. We used homemade powdered paint to color our sand, but you can also use watercolors or powdered tempera. 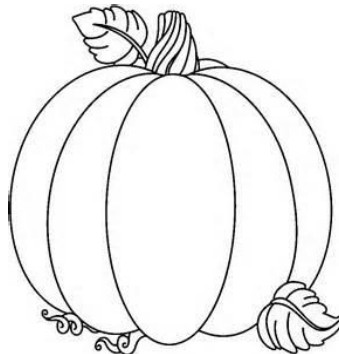
