### **Olmsted County Licensing News**

Hello Olmsted County Family Child Care Providers,

The following is information regarding a few items that we have been receiving questions about:

### **Annual, Unannounced Licensing Inspections**

The Federal Child Care Development Block Grant Reauthorization includes several new federal requirements for family child care. The Minnesota Department of Human Services is in the early stages of planning for the changes. One of the new requirements is annual licensing inspections for child care centers and family care. Currently inspections are required every two years. These inspections are to be completed as unannounced visits. It is expected that this requirement will be effective November 19, 2016.

As you are aware, Olmsted County already completes annual inspections. These inspections are unannounced and occur during the month prior to the license expiring or on the off-year. Due to this practice, Olmsted County family child care providers will experience little, if any, effect from this new federal requirement.

\*\*\* Please note that not all counties in Minnesota currently complete annual inspections and/or unannounced visits.

### Monitors Placed in Infant Sleep Space (Example: Owlet Baby Monitor)

MS 245A.1435 Reduction of Risk of Sudden Unexpected Infant Death in Licensed Programs.

(b) "....The license holder must not place anything in the crib with the infant except the infant's pacifier".

The Owlet Baby Monitor in the sock goes beyond clothing and would be considered as placing something other than the infant's pacifier in the crib.

DHS reported that the MN SIDS Center and the American Academy of Pediatrics recommendations clearly state that monitors should not be used as a strategy to prevent deaths. There is no evidence that monitors are effective. Following safe sleep practices has been proven successful.

### Storage of "Ice Melt" and Other Toxic Substances

Rule 9502.0435 Sanitation and Health. Subp. 4. Toxic Substances. All medicines, chemicals, detergents, poisonous plants, alcoholic beverages, and other toxic substances must be inaccessible to children.

Ice melt products are considered to be toxic substances as they can be harmful to children and pets. The license holder must store these products in an area that is inaccessible to children or have them in a container on which the lid is not able to be removed or opened by a child.

### **Emergency Substitutes**

Rule 9502.0435 Sanitation and Health. Subp. 8D. Prior arrangements must be made for a substitute to provide care during emergencies.

All providers are required to have an emergency substitute. Your identified emergency substitute must have a current cleared FCC licensing background check and have the required training for a substitute.

A correction order may be issued at visits completed after August 1, 2016 if no emergency substitute has been identified and/or the substitute does not have the required background check or training.

### Southern Minnesota Initiative Foundation's Quality Child Care Program

A 2008 report showed that only about 50 percent of Minnesota's children were ready for kindergarten. Southern Minnesota Initiative Foundation recognizes the long-term cost of not having all our children receive a strong academic start.
