Give each child the tools for adventure, let them be artists and writers and more;

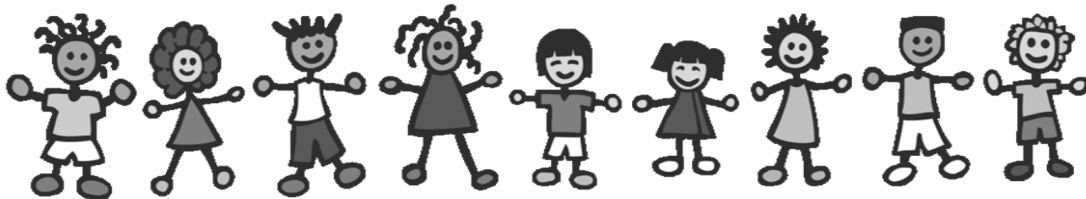
Let them fly in the wind and dance on the stars and build castles of sand on the shore.

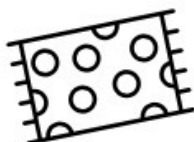

Olmsted County Licensing News

Spring 2019

Emergency Preparedness Plan

During 2019, licensors will be checking that providers have an Emergency Preparedness Plan, that the plan is complete, and that it is posted in a prominent place. The license holder will receive a correction order if these items are not in compliance.

New Licenses have a different look!!

Yes, they look different, there is no green border and they are plain looking. And, yes, DHS is aware that they do not have the same "professional look" and that license holders have been commenting on this. DHS is working on resolving this issue with their printing technology. For now, this is the "look" and the license you receive from DHS is the "real deal".

Expiration dates on new licenses

New licenses being printed by DHS will have a different expiration from what you've been used to seeing in the past. The newly issued license will be effective the first day of the month and will expire on the last day of the month. For example, for a license renewal, the effective date is 1/01/2019 and the expiration date is 12/31/2021.

Legal names on the license

From now on, your child care license needs your exact, legal name to be issued.

We cannot accept nicknames (i.e. Hank and the license holder's legal name is Henry; or Beth, and the license holder's full name is Elizabeth). If you have a hyphenated last name or two last names, and this is your legal name, then that is what must be recorded on your licensing paperwork and on the background study paperwork (once Olmsted County begins that process).

Background Studies

Background studies are no longer tied to a License Holder's relicensing date. You will be notified by DHS and Olmsted County when it is time for you to complete the new NETStudy 2.0 background study process.



Reminder: A new background study needs to be completed when you have:

- A new household member
- A household member turning age 13
- A household member turning age 18
- A new substitute, second adult caregiver, or helper

Remember, you can access the Olmsted County website for child care forms, updates, provider information, the monthly orientation schedule, and more.

Advocacy



This has been a busy legislative session. There have been several bills presented in the House and Senate. Governor Walz has presented a bill, HF2184. This bill includes changes to special family day care homes, DHS authority to grant variances for use of substitutes, training requirements, emergency preparedness plan, telephone requirement, fire code changes, supervision and use of substitutes, background studies, and repealer. DHS has had two Stakeholder Webinars during the month of March to go over the possible changes.

Advocacy member, Barb Kylo, went up March 5th to a house committee meeting to speak on HF 740 that Representative Duane Quam authored. This bill is about finding a more respectful and professional manner to ensure parents have the phone numbers they need, if they need to contact someone about the care their child is receiving. This bill would remove the giant, bold print from our child care license. Licensing has been encouraged via testimony, to place this information on a form already in existence. These are forms that we already give parents to take home with them, it was suggested to add it to the reporting abuse policy form. Advocacy is optimistic about this bill and will update you as changes occur. Thank you Barb for your testimony!

Ariane Bromberg will be stepping down as Advocacy Chair at the end of this legislative session ending in May 2019. 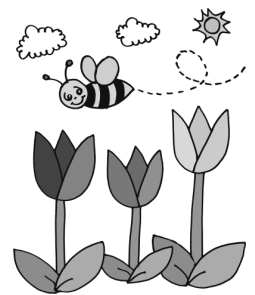
